THE STARTER REPORTED:

- a) BUMBLE BEE was stubborn loading.
- b) MAKEOVER MAGIC was stubborn loading and jumped slow, losing one length.
- c) DESTREGA jumped slow, losing one length.

THE STIPENDIARY STEWARDS REPORTED:

- a) All horses selected for TCO2 were within the required levels and no retests were recorded. (11h33)
- b) At approximately the 1000m, AMONG THE WILLOWS had to be steadied momentarily when awkwardly placed between the inside running rail and BUMBLE BEE, which shifted in. Thereafter, at approximately the 800m, AMONG THE WILLOWS had to be steadied and directed inwards to avoid running onto the heels of BUMBLE BEE, which shifted outwards away from the inside running rail.
Apprentice BA Makhubo was charged with a contravention of Rule 62.2.7 in that as the rider of BUMBLE BEE, he failed to ensure that he did not cause interference to AMONG THE WILLOWS, on two occasions, at the 1000m and the 800m. Apprentice BA Makhubo signed an Admission of Guilt and is suspended from riding in races for a period of 7 days. (Dates: 29/08/2026 to 04/09/2026, both dates inclusive).
- c) AMONG THE WILLOWS was hanging in from the 400m and corrected at the 100m.
- d) In view of the report from the Starter regarding BUMBLE BEE and MAKEOVER MAGIC, Trainers Z Oosthuizen and Assistant Trainer FJ Jacobs, acting on behalf of Trainer DG Smith, were advised to have these fillies re-schooled prior to their next engagement in terms of Rule 61.6.10.
- e) Jockey C Maujean reported that he felt something amiss with HAWKER TEMPEST. The Veterinarian was requested to examine this filly.
- f) MAKEOVER MAGIC, the winner, was selected for the taking of specimens for analysis. Assistant Trainer FJ Jacobs, acting on behalf of Trainer DG Smith, was advised. (LM)

THE STARTER REPORTED:

- a) GREY EAGLE (GB), KAILUA BREEZE and MAGNIFY were slow into stride.

THE STIPENDIARY STEWARDS REPORTED:

- a) All horses selected for TCO2 were within the required levels and no retests were recorded. (12h10)
- b) Permission was granted for GREY EAGLE (GB) to be assisted by a lead pony when proceeding to the start.
- c) GREY EAGLE (GB) over raced in the early and middle stages.

Assistant Trainer FJ Jacob's explanation was noted.
- h) Trainer K Mitchley was charged with a contravention of Rule 39.7.5 in that she failed to vaccinate KAILUA BREEZE against Equine Influenza in accordance with the program of vaccinations as published from time to time in the Racing Calendar. Stable Employee GW Paddock, acting on behalf of Trainer K Mitchley, signed an Admission of Guilt and Trainer K Mitchley was fined R1 000.00.

ADDENDUMS

07/08/2026 – Fairview Racecourse

The National Horseracing Authority confirms that, at an Inquiry held in Gqeberha on Friday, 14 August 2026, Jockey X C Ndlovu was charged with a contravention of Rules 77.1.1 and 77.2.1.

The charge arose from Jockey Ndlovu presenting himself to ride at Fairview Racecourse on 7 August 2026 while having a banned substance, namely alcohol, in his system.

Jockey Ndlovu pleaded guilty to the charge and was found guilty as charged.

After considering the mitigating and aggravating factors presented during the Inquiry, the Inquiry Board imposed a suspension from riding in races for a period of thirty (30) days, nine (9) days of which were wholly suspended for a period of one (1) year, on condition that Jockey Ndlovu is not found guilty of a contravention of Rule 77.1.1 or Rule 77.2.1 during the period of suspension.

Jockey Ndlovu was advised of his right to appeal against both the finding and the penalty imposed and waived his right to appeal.

Accordingly, Jockey Ndlovu is suspended from riding in races from 15 August to 4 September 2026, both dates inclusive.

10/08/2026 - Fairview Races

Jockey J Gates did not ride at today's race meeting – to be investigated.

Jockey J Gates explained to the Board that he had advised Trainer E Kaknis that he was not available to ride on Monday 10 August. However, Trainer E Kaknis had not attended races on that day and had failed to nominate a delegate to represent him, for which he was issued with an Admission of Guilt. As a consequence, the message from Jockey J Gates regarding not being available to ride on the day did not get relayed to the Stewards.

Jockey J Gates was advised that, in future, he needed to communicate with both his Trainer and the Stewards.
