- GREENSIDE GIRL refused to jump until the field had covered approximately 100 metres.
- CUBA LIBRE lost 2 lengths.
- CRIMSON FLAME lost 3 lengths.

THE STIPENDIARY STEWARDS REPORTED (DA) :

- All horses selected for TCO2 were within the required levels and no retests were recorded.
