- a) TURN TO THE LAW lost 1 length.

THE STIPENDIARY STEWARDS REPORTED (SR) :

- a) All horses selected for TCO2 were within the required levels and no retests were recorded.
- b) ASGARDIAN QUEEN stumbled badly leaving the starting stalls, dislodging Jockey A Mgudlwa. The Course Paramedics attended to Jockey A Mgudlwa which resulted in him being incapacitated from weighing back in. The Board acting in terms of Rule 66.2, deemed his weight to be correct.
- c) At the 900m, LADY JEROME was steadied to avoid the heels of the rider-less horse, ASGARDIAN QUEEN.
- d) Approaching the 700m, DANCING PARTY was steadied away from the heels of the rider-less horse which continued to roll in.
- e) At the 400m, DANCING PARTY was steadied to avoid the heels of the rider-less horse which rolled out and again at the 200m.

En-route to the start, Jockey A Mgudlwa (A M C ROY ON FIRE) indicated to the Course Paramedics that he felt unwell and required Medical attention. A replacement rider was sought, weighed out and dispatched to the start. This caused the delay to the start of this Race.

THE STARTER REPORTED:

- a) YUKINKO was stubborn to load.

THE STIPENDIARY STEWARDS REPORTED (SR) :

- a) All horses selected for TCO2 were within the required levels and no retests were recorded.
- b) CAMPO FORMIO, OCTOBERE RUSH, MUSTANG HIGHWAY and DANNY ATLAS raced green.
- c) At the 250m, STEALTH MODE was steadied and directed to the outside of YUKINKO to continue its run.
- d) Jockey K de Melo reported that YUKINKO did not stride out freely in the running. The Veterinarian was requested to examine.
- e) In view of the performances of RACHEL'S BOY (12.10 lengths, 33/1 in the betting) and HOLLYWOOD VISION (9.30 lengths, 200/1 in the betting) the Veterinarian was requested to examine.

The start of this Race was delayed due to the delay in the previous Race.

During the loading process (12:59:52), ANYTHING BUT LOVE reared over and dislodged Jockey M Thackeray and cantered back to the parade ring. This filly was taken in hand, examined by the Course Veterinarian, declared fit to race, was despatched to the Start, re-united with the rider and when attempted to be re-loaded, this filly reared over on the inside running rail and was subsequently withdrawn by the Veterinarian. This caused a further delay to the start of this Race.

THE STARTER REPORTED:

- ANYTHING BUT LOVE refused to load and reared over dislodging Jockey M Thackeray. Withdrawn by the Veterinarian.
- LEGAL TANGO and LAGERTHA THE QUEEN were stubborn to load.
- BLENHEIM PALACE and LILBITOFMONICA lost 1 length.

THE STIPENDIARY STEWARDS REPORTED (SR) :

- All horses selected for TCO2 were within the required levels and no retests were recorded.
- MARGAUX failed to parade in front of the grandstand. Trainer F Greyling will be advised that should this filly behave similarly in future it may be suspended.
- SARSDEN SURPRISE over-raced in the early stages.
- LAGERTHA THE QUEEN over-raced in the early stages and proved difficult to assist.
- Approaching the 1300m, BAI YULU, INDIGNATION, LEGAL TANGO were carried out by RED HOT MISS which rolled out. As a consequence, PACIFIC MOOD was inconvenienced on the outside, on the heels of LAGERTHA THE QUEEN, which was steadied out away from the heels of LEGAL TANGO.
- MARGAUX hung in from the 500m.
- In view of ANYTHING BUT LOVE rearing over and proving very difficult to load, the Board acting in terms of Rule 93.2.4, has suspended this filly indefinitely until such time it proves tractable to load and jump on terms with a companion on a race day. Trainer A Wright will be advised.
- RED HOT MISS, the winner, was selected for the taking of specimens for analysis. Trainer D Moore was advised (MM).
