THE STARTER REPORTED:

- a) ERIK'S STAR was stubborn loading and thereafter restless in the stalls.
- b) KORCULA stood, losing many lengths. The starting stall certificate for this filly has been withdrawn. Trainer F Bronkhorst was advised
- c) LEANNE'S LOVE was slow, losing two lengths.

- f) In view of the Starter's report with regard to KORCULA, this filly's starting stall certificate has been withdrawn, and she is suspended in terms of Rule 61.6.10 for a period of 7 days and until such time as she proves tractable loading and jumping with a companion. Suspension dates: 20 August 2026 to 26 August 2026. KORCULA may not be presented for re-passing during this period. Trainer F Bronkhorst was advised.
- g) When questioned regarding the improved performance of LEANNE'S LOVE, Trainer H van der Westhuizen could offer the Board no suitable explanation. His attention was drawn to the Rules pertaining to In and Out running.
- h) BEAUTIFUL ONE, the winner, was selected for the taking of specimens for analysis. Trainer F Bronkhorst was advised (MduP).

THE STARTER REPORTED:

- a) SIVAJI was slow into stride.

THE STIPENDIARY STEWARDS REPORTED:

- a) FOREVER RED raced wide around the turn and into the straight.
b) Approaching the 150m, ECHO OF THE WILD had to ease to avoid the heels of FUTURE RED, after being carried in by UNCLE BOB, which shifted in away from the crop.
Jockey C Zackey was charged with a contravention of Rule 62.2.7 in that he, as the rider of UNCLE BOB, failed to ensure that he did not cause interference to ECHO OF THE WILD (C Murray) when he shifted in approaching the 150m. Jockey C Zackey signed an Admission of Guilt and is suspended from riding in one (1) Central Province Racemeeting.

c) Apprentice J Botes, the rider of CUZZIE, accidentally dropped his crop at the 150m.

THE STARTER REPORTED:

- a) During the loading process, TITANS OF WAR kicked the back gates, resulting in OLYMPIAN GOLD becoming restless and breaking through the front gates. This colt was restrained by Jockey P Mxoli, returned to the start, examined by the Veterinarian, passed fit to race and reloaded. Assistant Trainer C Botha, acting on behalf of Trainer R R Wagner, was advised to reschool TITANS OF WAR prior to his next engagement (GT). Trainer S J Gray was advised to reschool OLYMPIAN GOLD prior to his next engagement (GT).

THE STIPENDIARY STEWARDS REPORTED:

- a) All horses selected for TCO₂ were within the required levels, and no retests were recorded.
- b) At approximately the 250m, TITANS OF WAR was steadied momentarily when awkwardly placed between ROYAL EDITION, which rolled out, and OLYMPIAN GOLD, which shifted in away from the crop. Thereafter, in the concluding stages, ROYAL EDITION was carried in by OLYMPIAN GOLD, which continued to shift in away from the crop. An objection was lodged by Jockey K de Melo, on behalf of the third-placed horse, TITANS OF WAR, against the second-placed horse, ROYAL EDITION, on the grounds of interference at the 250m. The Board, after giving regard to the evidence presented by the relevant parties, as well as the dual movements of ROYAL EDITION and OLYMPIAN GOLD, could not be satisfied that sole blame could be apportioned to ROYAL EDITION and therefore overruled the Objection and allowed the Judges' result to stand. Jockey K de Melo's deposit was refunded.
- c) OLYMPIAN GOLD, the winner, was selected for the taking of specimens for analysis. Stable Employee P de Palma, acting on behalf of Trainer S J Gray, was advised (MduP).
